Refund Policy - Refunds are limited and apply only to tuition; fees are not refundable. For details, please see the refund policy on the web page: www.cesl.arizona.edu/Documents/WithdrawalRefundPolicy.pdf CESL gives no refunds except in documented, extenuating circumstances. All refunds must be approved by the program administrator and require surrender of the original receipt. If payment was made by cash or check, refunds are processed through the University check request system. Note that this process can take 4-6 weeks. Credit card refunds are processed directly by CESL via credit back to the card that was used for payment. Classes cancelled by CESL will be refunded in full with the original receipt.

- Students must begin study at the beginning of a regularly scheduled 8-week session. If they study less than the full 8 week session, tuition will be calculated with the “per week” rate.
- The regularly scheduled June and July, one-month sessions are ½ of the regularly scheduled 2-month sessions.
- CESL classes are scheduled between 8:00 AM to 5:40 PM. You may have class at any time between these hours.
- US Citizens or Permanent Residents living in the US are not required to buy health insurance, but must show proof of current health insurance coverage and complete and sign the Refusal of CESL provided health insurance: <http://www.cesl.arizona.edu/docs/InsuranceHealthRefusal.pdf>
